International Study Experience

		Students must take 3 hours of approved Study Abroad or Exchange Program courses or an approved international internship to fill this slot. IMPORTANT – Students must get approval from the Associate Dean for Undergraduate Business Programs <u>before</u> signing up for the credit to be used in this slot. Students are required to work with a Staff Advisor in the Advising Center (BB431), and the Staff Advisor will present the request for approval to the Associate Dean. Processing of requests for approval of Exchanges, internships, & non-Coles SAs takes 4 weeks, so start early! (continued)	3

		<p>Students studying at KSU on an F-1 Student Visa should meet with a Coles Staff Advisor to discuss a special option for this Requirement.</p> <p>While the course used for this slot is not required to be a business course, it is strongly recommended that the course be in business or in your foreign language to maximize its benefit. Ideally a business course used here would be additional work in your Concentration Area. If your international study experience course will count elsewhere in the degree (e.g., in your Foreign Language Requirement area), you will have to take 3 hours of an upper-division elective approved by the Associate Dean to fill this slot.</p> <p>No courses are automatically placed in this slot by the Registrar’s Office. After the pre-approved SA, Exchange, or international internship is completed and the grade is official, you must meet with a Coles Staff Advisor to request paperwork be sent to the Registrar’s Office documenting the Associate Dean’s approval to count it here.</p> <p>***If you take a 6-hour Coles Study Abroad trip, and the second 3 hours will not fit elsewhere, please meet with a Coles Staff Advisor <u>before</u> signing up for the trip to discuss a possible option for counting the second course in the IB Major Field Requirements section. This option would have to be approved by the Associate Dean prior to signing up for the trip.</p>	

***Coles College of Business – Sophomore GPA Requirement – Business majors who first enroll at KSU in Fall 2004 through Summer 2008 must complete the seven lower-division business core courses plus a calculus course with an adjusted GPA of 2.875 or higher, and be admitted to the Coles Undergraduate Professional Program, in order to be eligible to enroll in upper-division business courses. A grade of “C” or better is required in each of these courses. Regardless of whether these courses are taken at KSU or another acceptable accredited university, their grades will be used in this GPA calculation. If KSU brings in a transfer course with something other than 3 hours credit, that will affect the GPA calculation. Once you have satisfied the Sophomore GPA Requirement your next step is to apply to the Coles Undergraduate Professional Program.**

****If you completed BISM 2100, you do not have to take IS 2200.**

“Department Chair” Approval – Because the International Business Major is interdisciplinary, any paperwork or other process that requires “Department Chair” approval, including business course substitutions, must be approved by the Associate Dean for Undergraduate Business Programs. Approval from one of the Department Chairs will not be sufficient. The first step required to request approvals from the Associate Dean is to meet with a Coles Staff Advisor in the Undergraduate Business Advising Center (BB 431). You will discuss and submit your information to the Advisor, who will present your request to the Associate Dean on your behalf. If needed, you may have to submit additional information by email. If so, always include your KSU ID number, Major, and Concentration Area in your email.



NOTES –

1. **Additional Information/Updates** – This checksheet does not describe all of KSU’s policies and requirements. You must follow all the rules that are in the *KSU Undergraduate Catalog*. We have worked hard to ensure the accuracy of the information in this checksheet up to the date shown below. Be sure to check regularly for revisions/updates to this info.
2. **Prerequisites** – Check the most recent edition of the *KSU Undergraduate Catalog* for course prerequisites. Students are responsible for meeting a course’s current prerequisites even if they changed after the student started at KSU. The *Catalog* is online at catalog.kennesaw.edu.

3. KSU Grade Requirements –
 - Starting Fall 2011, business majors must earn a grade of “C” or better in *ALL* business courses counted toward their degree. If a business course was taken prior to Fall 2011, a grade of “C” or better was required except for the courses counted in the “Business Electives” section of the degree. In addition, IB Majors must get a “C” or better in the courses used for their Foreign Language Requirement and their International Study Experience Requirement.
 - Students must earn at least a 2.0 GPA to receive a degree from KSU.
4. KSU Residency Requirements – In order to receive a business degree from KSU:
 - All students must complete at least 33 semester hours of business courses at KSU, including at least 24 semester hours of upper-division business courses.
 - All students must complete at least 12 semester hours of their Major Field Requirements and Major Field Electives at KSU.
 - All students must complete at least 20 of their last 30 semester hours before graduation at KSU.
5. You must graduate following the program requirements in a *KSU Undergraduate Catalog* that is not more than 10 years old at the time of graduation. If you do not graduate within 10 years of starting at KSU, you will have to move up to a more recent *Catalog* and meet all of the program requirements in it. Also, if you stay out of school for several terms and KSU requires you to be readmitted when you come back, you will have to follow the *Catalog* in effect for the term you are readmitted.
6. All General Education requirements do not have to be completed before beginning business coursework, but the English composition and the Math courses should be completed right away as they are prerequisites to certain business courses.
7. Disclaimer: Completion of this check sheet does not insure that graduation requirements have been fulfilled. Only the KSU Registrar’s Office can say whether all graduation requirements have been met. Submit your petition to graduate to them as soon as you are eligible (at the beginning of the term before the term you want to graduate).
